- 2. The property and all rights shall be passed on from Appstreet Technologies Private Limited (Transferor Co.) and Rackbank Datacenters Private Limited (Transferee Co.) becomes the absolute owner upon such delivery and transfer.
- 3. All other statutory dues and liabilities relating to said SEZ Business Units and accruing about the period after the closing shall be discharged by the Rackbank Datacenters Private Limited (Transferee Co.). Appstreet Technologies Private Limited (Transferor Co.) will be responsible for all dues and liabilities till the closing.

No revision in Projections

In this connection, we would also like to indicate here, thatthere will be no revision in the projections for Exports, Investments and Employment, etc. w.r.t. Change of entrepreneur as this is a mere change in implementing agency by way of Slump Sale Agreement, wherein transferee company will take over the transferor business and transferee company will be into SEZ as an ongoing entity. Hence, there will be no revision in projections.

The brief facts of the case are as follows:

- Commencement of Commercial

operation : March 26, 2020.

As per instruction no. 109 dated October 18, 2021, reorganization, including change of name, change of shareholding pattern, business transfer arrangements, court approved mergers and demergers, change of constitution, change of Directors, etc., may be undertaken by the Unit Approval Committee (UAC) concerned, subject to the condition that the Unit shall not opt out or exit out of the Special Economic Zone and continues to operate as a going concern. All liabilities of the Unit shall remain unchanged upon such reorganization.

In the present case, the transferee entity, i.e., M/s. Rackbank Datacenters Private Limited, has submitted an undertaking for the same.

The case is within the ambit of Rule 19(2) as well as 74-A of the SEZ Rules, 2006, wherein the following is mentioned:

- 1. **Rule 19(2):** [Provided also that, subject to the provisions of Rule 74-A] the Approval Committee may also approve the change of the entrepreneur of an approved unit if the incoming entrepreneur undertakes to take over all the assets and liabilities of the existing unit.
- In the present case, the transferee entity has submitted an undertaking for the same.
 - 2. **Rule 74-A:** The Unit may opt out of SEZ by transferring its assets and liabilities to another person by way of transfer of ownership, including the sale of SEZ units, subject to the following conditions:
 - a. The unit has held a valid LOA as well as a lease of land (or standard Design Factory) for not less than a period of five years on the date of transfer.
 - In the present case, the transferor unit possesses a lease deed dated October 29, 2020, and their LOA is valid (after the commencement of operation for the first block of five years, i.e., from March 26, 2020, to May 25, 2025.
 - b. The unit has been operational for a minimum period of two years after the commencement of operations/production as of the date of transfer.
 - In the present case, the transferor unit has been operational since March 26, 2020.
 - c. Such sale or transfer transactions shall be subject to the approval of the Approval Committee.
 - d. The transferee fulfils all eligibility criteria applicable to a unit, and

The applicable duties and liabilities, if any, as calculated under Rule 74, as well as export obligations of the transferor unit, if any, shall be transferred to the transferee unit, which shall be under obligation to discharge the same on the same terms and conditions as the transferor unit.

In the present case, the transferee entity has submitted an undertaking for the same. The Approval Committee may kindly consider and decide on the request of the unit for change in the entrepreneur along with the change in the name of the unit, in terms of Rules 19(2) and 74-A, read with DOC's Instruction No. 109.

<u>Decision of the Approval Committee</u>: The case is differed as information is being sought from Income Tax Department in the matter.

Subject: - Approval of list of goods & services required for Authorized Operations; request of the Co-Developer M/s. Shivalik SEZ Projects LLP in GIFT-SEZ, Gandhinagar — Under Section-14 (1) (a) of the SEZ Act, 2005, read with Rule-10 & 12 of the SEZ Rules, 2006.

Sector Specific SEZ for Multi-services, being developed by M/s GIFT Company Limited (formerly M/s. GIFT SEZ Limited), Gandhinagar was notified for an area of 105-43-86 Hectares at Villages Phirozpur and Ratanpur, District Gandhinagar vide Notification No. S.O.1910 (E), dated 18-08-2011. Further, an area of 61-18-29 Hectares and an area of 44-25-57 Hectares were demarcated as processing and non-processing area respectively on 26-11-2015. The ministry of Commerce & industry has approved the default list of Authorized Operations to be undertaken by the developer in the notified area, vide instruction no. 50, dated 15-03-2010 and for the approved Authorized operations vide letter dated 07-03-2012 of the DOC.

Further, the Government of India has approved a co-developer namely M/s. Shivalik SEZ Projects LLP, vide letter No. F.1/145/2007-EPZ, dated 10-07-2024,

for construction, development, maintenance, and operation of commercial building over an area admeasuring 47379.54 square meters within the Processing Area of GIFT-SEZ, Gandhinagar.

The Co-Developer (Shivalik SEZ) vide their letter dated 12-07-2024 (copy enclosed) has now sought approval for procurement of duty-free goods required for the default authorized operations, viz. "construction of all types of building". The duty-free goods required are for basic development, civil/construction, and other related infrastructure work in the notified SEZ. The Co-Developer has submitted the requisite Chartered Engineer's certificate for the proposed activities to be undertaken, for the authorized operations.

The Approval Committee may kindly like to accord approval for duty free procurement of goods for undertaking authorized operations in the notified area of SEZ, as per list the enclosed with letter dated 12-07-2024 of the co-developer (Shivalik).
